WAIVER & ACKNOWLEDGMENT OF RISK, RELEASE OF LIABILITY AND AGREEMENT

I am registering for either the 2010 Boulder Marathon or Boulder Spring Half, ("The Race" or "Event"), and associated activities, and I am fully aware that these activities involve risks. I accept all the risks of participating, even if they are created by the carelessness or negligence of a released party or anyone else. I know that participation in the event is a potentially hazardous activity and involves inherent risks which may potentially result in serious injury, illness or death. I will not participate in the event unless I am medically able to do so and properly trained. I assume all risks associated with participating in the event, including but not limited to the effects of weather, traffic, course conditions and course surfaces, falls, illness, and contact with other runners, volunteers and spectators. I know there are other risks that are not listed. I fully release, discharge and waive any claims I may have, now or in the future, against the released parties, even if claims are based on the carelessness or negligence of a released party or anyone else. "Claims" as used in this document means any and all liabilities, claims, demands, legal actions, and rights of action for damages, personal injury or death that are related to or in any way connected with participation in the race activities that I or my heirs or personal representative could make. "released parties" as used in this document means Boulder Marathon LLC, City and County of Boulder, all sponsors of the race activities (and the governing bodies, directors, officers, representatives, agents, employees, medical personnel, and volunteer staff of each of them.) I agree not to sue released parties for claims, even if the claims arise from the carelessness or negligence of a released party or anyone else. I agree to indemnify (reimburse for any loss) and hold harmless each released party from any loss or liability (including any reasonable attorneys fees they may incur) defending any claim made by me or by anyone making a claim on my behalf, even if the claim is alleged to or did result from the carelessness or negligence of a released party or anyone else. I am aware that there is no obligation for any person to provide me with medical care during the race activities. If medical care is rendered to me, I consent to that care if I am unable to give my consent for any reason at the time that the care is rendered. I am aware that it is advisable to consult a physician prior to participating in the race. If I have consulted one, I have taken the physician's advice. I grant my permission to Boulder Marathon LLC, the sponsors of the race activities and any transferee or licensee of any of them, to utilize any photographs, motion pictures, videotapes, recordings and any other references or records of the race activities which may depict, record, or refer to me for any purpose, including commercial use by Boulder Marathon LLC, its sponsors and their licensees. I agree to abide by the rules of the race activities. I am aware that the rules prohibit baby strollers/joggers, pets on the course, and any wheeled equipment, such as bicycles. I acknowledge that, if I violate any of these prohibitions or other rules, I may be removed from the course and the permission for me to participate in the race activities may be withdrawn by representatives of Boulder Marathon LLC. I have fully read and understand this document. No warranties or representations have been made to me about the race activities which are not stated on this form. I understand and intend that this document act as the broadest and most inclusive assumption of risk, waiver, release of liability, and agree not to sue and indemnify as is permitted by the laws of the State of Colorado. The singular of nouns and pronouns in this document includes the plural and the plural includes the singular. I agree that the laws of the state of Colorado shall govern its interpretation and enforcement.
